**NOTIFICATION OF THE BOARD OF GOVERNORS

**Re: Fee Schedule for Listing of Depository Receipts
as Listed Securities B.E. 2558 (2015)**

By virtue of Clause 11 of the Regulation of the Stock Exchange of Thailand Re: Listing, Disclosure of Information and Delisting of Depository Receipts B.E. 2558 (2015), dated May 7, 2015, the Board of Governors of the Stock Exchange of Thailand hereby issues the following provisions:

1. This Notification shall come into force on May 16, 2015. **Effective Date**

2. Fees for listing of the Depository Receipts as Listed Securities shall be in accordance with the rates specified in the Schedule attached hereto. **Fee Rates**

3. The Issuing Company shall pay the annual fees in advance for the subsequent year, the period of which shall be from 1st of July of a current year until 30th of June of the subsequent year, and that shall be regarded as an annual fee year. In the case that the Depository Receipts are Listed Securities for the fraction of any annual fee year, the annual fee shall be calculated in proportion to the period which such Depository Receipts are listed. **Period of Annual Fee**

The calculation of the first year's annual fee shall be based upon the value of the Depository Receipts on the filing date. The annual fee for the subsequent year shall be calculated from the value of the Depository Receipts on the commencement date of the relevant annual fee year.

4. The following fee rates shall be applied to the Depository Receipts, which the Issuing Company proceeds the trading on the Stock Exchange from the Effective Date of this Notification until 31st December 2016: **Fee Rates of Depository Receipt which commences trading from the Effective Date hereof until 31st December 2016**

(1) the application fee, initial listing fee and the fee for additional Depository Receipts shall be exempted; and

(2) the annual fees for the years of 2015 and 2016 shall be at the rate of Baht 10,000 per annum.

Fee Schedule for the Listing of Depository Receipts

Category	Fee Rates
1. Application fee	- Baht 50,000
2. Initial listing fee	- 0.05 percent of the value of the Depository Receipts, with the minimum fee rate not less than Baht 100,000 and the maximum fee rate not exceeding Baht 3,000,000.
3. Annual fee	<ul style="list-style-type: none"> - 0.035 percent of the value of Depository Receipts for the amount not exceeding Baht 200 million; - 0.030 percent of the value of Depository Receipts for the amount exceeding Baht 200 million , but not exceeding Baht 1,000 million; - 0.025 percent of the value of Depository Receipts for the amount exceeding Baht 1,000 million, but not exceeding Baht 5,000 million; - 0.020 percent of the value of Depository Receipts for the amount exceeding Baht 5,000 million, but not exceeding Baht 10,000 million; - 0.010 percent of the value of Depository Receipts for the amount exceeding Baht 10,000 million, <p style="margin-left: 40px;">provided that the minimum fee rate shall not be less than Baht 50,000 and the maximum fee shall not exceed Baht 3,000,000.</p>
