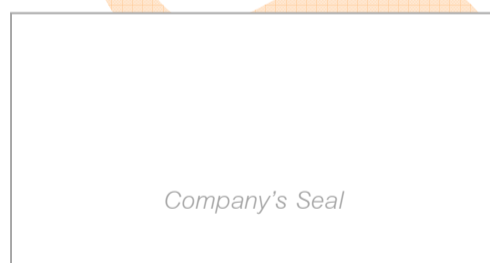

2. Existing Trading connection
 - 2.1. The fee for additional Throttles is at the rate of Baht 125,000 per throttle per month;
 - 2.2. The fee for additional Users is at the rate of Baht 5,000 per user per month;
3. Drop Copy connection
 - 3.1. The fee for additional Drop Copy connection is at the rate of Baht 5,000 per user per month;

Note: Such fees are not yet included of value added tax (VAT).

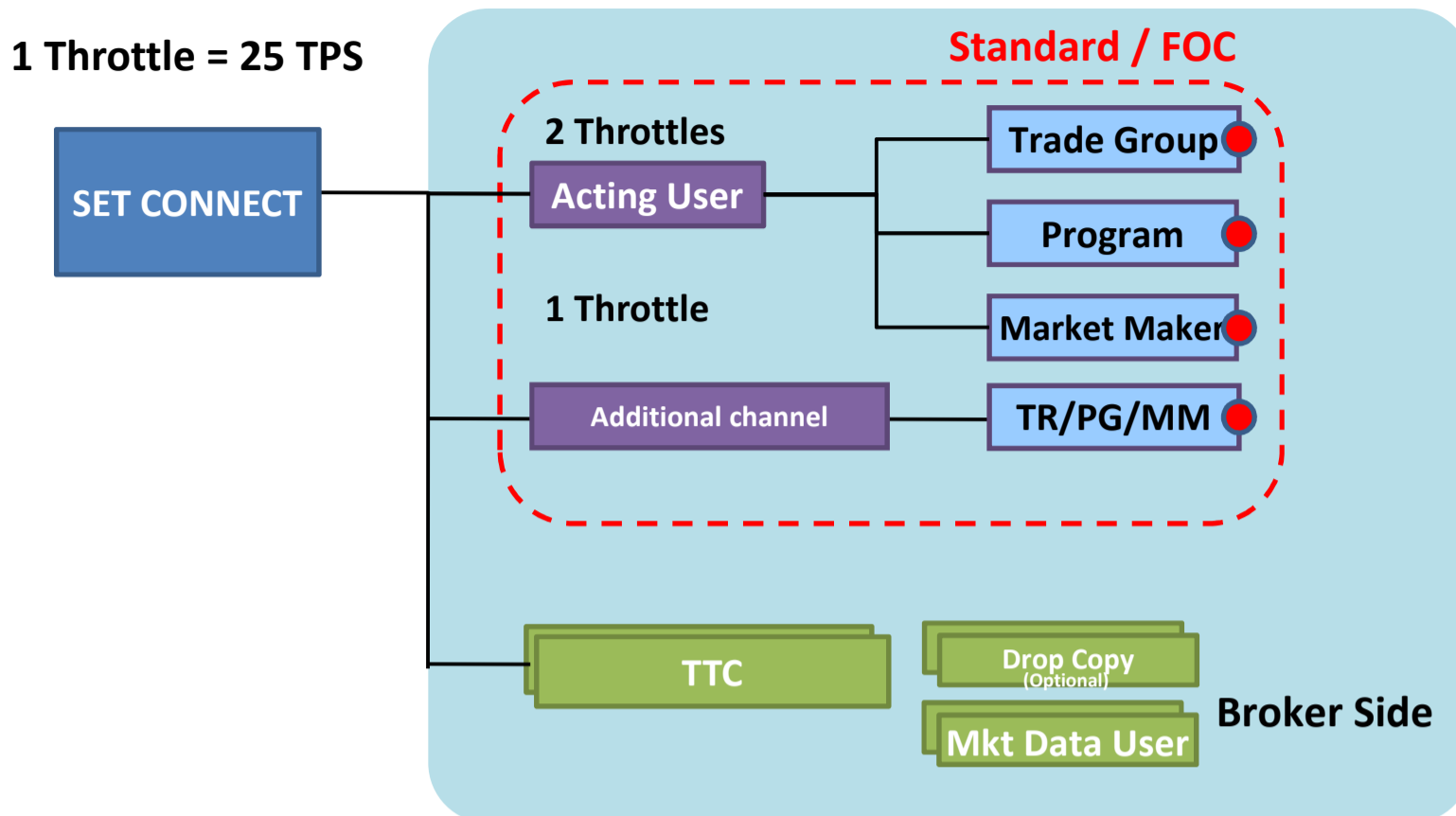
