

Checklist: Significant commercial contract gain or loss

Whenever the listed company engages in any significant contract gain or loss, it has the duty to report such information to SET immediately.

4. Expected benefits and impact from such loss	
<ul style="list-style-type: none"> Explain the expected benefits or impact that may happen to the company's business operation and guidelines to reduce the impact.
