Remarks:

1. Supporting documents for authorization are:

- Documents supporting each type of transaction for which there is authorization.
- Identification documents for each transaction.
- Original and copy of the identification card of the grantee.
- Copy of the identification card of the person who affixes the signature as witness.

2. The grantor must affix the signature to accompany any scraping, deletion, cross-out and addition in the power of attorney.

3. Affixation of stamp duty

- In case of authorization of one or several persons on a single occasion, THB 10 affixation is required.
- In case of authorization of one or several persons on more than one occasion, THB 30 affixation is required.

4. Copy of identification documents submitted to Thai NVDR may contain sensitive personal data which is not necessary for the provision of Thai NVDR service, and Thai NVDR has no intention of collecting such sensitive personal data. As a result, the document owners may proceed to cross out any part in order to cover up any sensitive personal data before submitting the identification documents containing such sensitive personal data to Thai NVDR. In case that no action is taken to cover up such sensitive personal data, Thai NVDR shall deem that you have given your consent to Thai NVDR to the collection of such sensitive personal data.

Remark : 1. Sensitive Data means the information which can be considered as the personal data as prescribed in section 26 of the PDPA, for instance, religious belief, blood type, etc.

2. Thai NVDR will consider the above documents when receiving the complete documents and clear information such as the copy of identification documents or signature.
