The Thai NVDR Company Limited (Thai NVDR) has changed prospectus Part 5 "Terms and Conditions of NVDRs" in accordance with Thai Laws pertaining to restrictions on investment. Thai NVDR would like to announce the change of prospectus as follows;

- 1. Split voting is now allowed for the meeting that has been called to consider the de-listing of shares from the Stock Exchange of Thailand. NVDR holders can make a split voting by dividing votes given to his proxy in to "agree-votes", "disagree-votes" and "abstain-votes". The existing NVDR holders who wish to exchange their NVDRs for shares must submit a request within 11 October 2002 to Thai NVDR through brokers, sub-brokers or custodian bank. Thai NVDR will proceed on 14 October 2002.
