This refers to the notification of the Office of the Securities and Exchange Commission No. Sor Jor. 38/2561 regarding the preparation of the report on changes in securities holding and derivatives holding of directors, executives, auditors, planners and plan administrators ("Notice of the SEC") by stipulating that the persons under Section 59 of the Securities and Exchange Act B.E. 2535 ("the Securities and Exchange Act") holding Non-Voting Depositary Receipt ("NVDR") have a duty to prepare and submit a report on the change of the holding of the NVDR to the SEC; and in the event of any violation of the said duty, there will be penalties as specified in Section 275 of the Securities and Exchange Act.

Therefore, in order for the SEC to be the primary unit in supervising and governing the regulations related to reporting in the holding of NVDR and the enforcement of penalties for those who violate and not in compliance with the Securities and Exchange Act, including eliminating duplication in the rules for reporting the holding of NVDR. Therefore, Thai NVDR Company Limited (the "Company") has amended the prospectus for the offering of NVDR ("prospectus") as follows. The amendments are effective from February 3, 2020 onwards.
