

"Singapore through Strait of Malacca via Laem Chabang Port"





Promote Targeted Industries Aviation and Logistics



- Thai Airways and Airbus will implement Maintenance, Repair and Overhaul (MRO) at U-Tapao.
- Equipped with latest systems for all major types of jetliners' maintenance and repair work using digital, analytic and other technologies as well as personnel training centre
- Promote aviation and other related industries

Expansion of Harbor Transportation Systems Map Ta Phut Industrial Port - Phase III



- To increase the capacity of natural gas and raw fluid material shipments for the petrochemical industry.
- Upon completion, the seaport will be able to accept 19 million additional tons of cargo (petrochemicals and natural gas) within 20 years.

Expansion to support growth

- Double containers accommodation, from 7 to 18 million TEU/year
- Increase car export accommodation, from 2 to 3 million units/year

- Move into world's **Top 10** ports
- Investment Value : 4.2 Billion USD






